SPECIAL BOARD MEETING MINUTES

OLD BUSINESS: Discussion and Possible Action on Ambulance Billing Agreement with Mediclaim Data Services Inc.: Chief Wunder – Mr. Whittington has finalized his review of the document. Mr. Katzel made a motion to approve this agreement. Mr. Allen seconded. All were in favor, and the motion was approved, (3-0).

A. Discussion and District Planning - Fire Chief Chuck Wunder

- 1. Overview Chief Wunder briefly discussed the general outline of the meeting.
- 2. EMS Operations Chief Wunder briefed the Board on the status of the final waiting period for the CON, as well as the Medicare application process. Chief Kosiorowski has ordered the new ambulance, and is currently working out billing rates for Medical/EMS supplies with AMR. Chief Wunder also discussed his plans for growing the ambulance fleet in the future, based

- on the needs of the program. The Board took a brief recess at 1:55 P.M. and returned back in session at 1:58 P.M.
- 3. District Growth and Expansion Chief Wunder advised the Board that Management/HR is ready to initiate another hiring process on October 18th; with the academy class planned for February.
- 4. Regional Fire and EMS Partnerships Beach Fleischman has submitted their initial draft of the Tri-District analysis. Chief Wunder shared his comments on the study to the Board, and the Board related their observations as well. Another Tri-District Board meeting is set for September 20, 2017.
